

Barnack Neighbourhood Plan

The Neighbourhood Planning (General) Regulations
2012 (as amended) – Regulation 16 Consultation

Barnack Parish Council has submitted its draft Neighbourhood Plan to Peterborough City Council. It sets out objectives for the future of the Barnack Neighbourhood Area and contains planning policies to guide the development and use of land in Barnack. This is a formal stage of consultation as required under Regulation 16 of the Neighbourhood Planning (General) Regulations 2012 (as amended). The consultation runs from Friday 22 January to 11:59pm on Friday 5 March 2021.
