Minutes of a Meeting of Barnack Parish Council held in The Village Hall, Barnack  
on Monday 14 April 2014 at 7.30 pm.

## Draft Minutes for confirmation at next meeting

- 1 To record Members present. **Harry Brassey, Vice Chairman; Eddie Barker; Ivor Crowson; David Laycock; Margaret Palmer and four Residents. Harry Brassey Chaired the meeting.**

  - a) *A Resident said they are very disappointed at the Council voting to disagree with the Tree Preservation Order on woodland north of Linden Close. They asked if any other Residents had complained, and whether the Council would reconsider its decision.*
  - b) **The Chairman reiterated the reasons for the Council not supporting the TPO:**
    - *The majority are self-sown Sycamore and possibly a Walnut or two on the boundary.*
    - *Sycamores can grow to a very large size, well over 100ft and with them being so close together they are totally inappropriate for this site.*
    - *If they do survive; as they mature they will in due course block out light from the houses on the south side of Payne's field.*
    - *Also, being so close together they will block out the light to the ground underneath them so nothing of any consequence will proliferate there it will just be barren ground, which is already happening, no wildlife, insects or plants.*
    - *They will also take moisture and nutrients from the fine row of Horse Chestnuts which are already under stress from the new houses in Linden Close.*
    - *The area is already turning into a tip as it is unmanaged.*
    - *The amenity value is minimal and the trees are not blocking any unsightly buildings or areas.*
    - *Not one Village Resident has come to discuss it with us, just an anonymous application to Peterborough City Council.*
  - c) *Bus stop post at the Terrace is too high and needs to be shortened.*
  - d) *The footpath between the War Memorial and Pilsgate has been narrowed by grass growing over the paved area and needs clearing.*

- e) *The footpath on Stamford Road between the War Memorial and the Allotments: weeds need clearing along the wall.*

15 Environment.

a) Verges maintenance. *Report by Margaret Palmer on identifying flower-rich verges to be left uncut during the summer: southern verge on Stamford Road between The Terrace and Mill Road, verge beside wall on Whitman Close. There is to be a meeting with the Wildlife Trust to discuss verge maintenance.*

b) Community Orchard. *Peterborough Environment City Trust are hoping to gain funding for community orchards for parishes. This could pay for approximately twenty trees for Barnack.*

c) Friends of Hills and Holes: Committee membership. (Ref: Item 16c of March 2014 Minutes) *Margaret Palmer attended a recent meeting and suggested, at the request of the Council, that a Parish Councillor should be on the Committee. This suggestion was not met favourably. The Committee said, that they would send meetings agendas and minutes to the Council and as Margaret was involved with the Friends that was probably sufficient. The Council agreed. It was also reported that the Friends are launching their organisation on 21 April with a photographic exhibition at the Millstone Inn, Barnack and an easter egg hunt.*

16 Multi Use Games Area. *Report by Harry Brassey: as the new site is outside the Village Envelope, Jim Daley, PCC Environment Officer, has suggested a pre-app for both sites. This has been submitted with pros and cons. (quotes have now been obtained and fundraising can start. (quotes Sutcliffe play £62,922; Wicksteed £64,255; Wild Cats in the region of £60,000. Another £22,000 will be needed for a play area.)*
